Lawson began his career at the US Department of Justice with a focus on endangered species and wildlife issues. Lawson received a Special Achievement Award in 2009 from US Attorney General Eric H. Holder. He also represented the US Coast Guard in litigation relating to the response to the Deepwater Horizon spill. Lawson served as a law clerk for Justice Walter L. Carpeneti of the Alaska Supreme Court. He earned a J.D. degree and a B.A. (cum laude) in environmental science and public policy from Harvard University.
