While at DOJ, Tanya handled a diverse docket of natural resources matters, including representing the Bureau of Land Management and Forest Service in Greater Sage Grouse litigation. In 2018, Tanya earned the Department of Justice Award for Outstanding Service.

Tanya's government service also includes serving as an Assistant United States Attorney for the U.S. Attorney's Office in Washington, D.C. There she served as first-chair in 35 bench trials of violent crimes and narcotics cases.

- Represents New Mexico local governments for recovery of costs to remediate municipal water supplies contaminated by hazardous substances used by private company
- Successfully settled and negotiated penalties in EPA enforcement action for industrial stormwater permit compliance under the Clean Water Act.
- Successfully co-defended preliminary injunction against the Bureau of Land Management and Forest Service decisions implementing greater protections for the Nevada Greater Sage-Grouse species and their habitat.
