

PFAS REGULATORY UPDATE FOR THE SNOW SHOW



REGULATIONS APPLYING TO ALL PRODUCTS

CALIFORNIA – Proposition 65 labeling requirements for PFOA and PFOS (reproductive toxicity and cancer), PFNA (reproductive toxicity).

MAINE – General reporting requirements for PFAS in all products sold in Maine starting 2023.

EPA – Proposed TSCA Reporting Rule: recordkeeping and reporting requirements for products containing PFAS imported or manufactured since January 1, 2011.

SKI WAX REGULATIONS

VERMONT - PFAS in ski wax banned starting July 1, 2023.

APPAREL REGULATIONS

CALIFORNIA – Manufacture, distribution, or sale of textiles (including apparel) containing intentionally added PFAS banned starting January 1, 2025. Exception for outdoor apparel for severe wet conditions.

CALIFORNIA – "Containing PFAS chemicals" label required for outdoor apparel for severe wet conditions containing PFAS starting January 1, 2025.

CALIFORNIA – Manufacture, distribution, or sale of outdoor apparel for severe wet conditions containing PFAS banned starting January 1, 2028.

NEW YORK – Ban on the sale of apparel containing intentionally added PFAS beginning January 1, 2024. Exception for high-performance outwear intended for extreme conditions. Signed into law with expectation of amendments to align with California.

WASHINGTON – Future rulemaking on textiles and apparel with intentionally added PFAS.



CHILDREN'S PRODUCTS REGULATIONS

CALIFORNIA – Sale or distribution of children's products containing intentionally added PFAS banned starting July 1, 2023.

VERMONT – Disclosure and reporting requirements for manufacturers of children's products containing PFOA or PFOS.

OREGON – Reporting requirements for PFOS in children's products, PFAS banned in mouthable products or items for children under three years old.

WASHINGTON - Mandatory reporting for PFOS and PFOA in children's products.

COLORADO – Sale or distribution of children's products that contain intentionally added PFAS banned starting January 1, 2024.



AFTERMARKET WATERPROOFING REGULATIONS

CALIFORNIA – Aftermarket fabric treatments containing PFAS require reporting notifications and phaseout plan.

MAINE – Sale of aftermarket fabric treatments with intentionally added PFAS banned starting January 1, 2023.

VERMONT – PFAS in aftermarket fabric treatments banned starting July 1, 2023.

COLORADO – Sale and distribution of aftermarket fabric treatments with intentionally added PFAS banned starting January 1, 2024.

WASHINGTON – Proposed ban on aftermarket fabric treatments with intentionally added PFAS starting January 1, 2025.
